Official Rules for Rhythm X, Inc. #xstagram Giveaway Sweepstakes

No Purchase Necessary. A Purchase will not Increase Your Chances of Winning.

- 1. Eligibility: The Rhythm X, Inc. #xstagram Giveaway Sweepstakes (the "Sweepstakes") is open only to legal residents of the United States who are at least eighteen (18) years of age.
